ACCIONA started its activity in Cabo Verde 2014 with the remodelling of the international airport terminal of Isla do Sal - Oasis (Am&#237;lcar Cabral) and the extension of the passenger terminal of the international airport of Boavista (Ar&#237;stides Pereira). In addition, the company has built two desalination plants

Where does Acciona Energia operate?

ACCIONA Energ&#237;a counts with an active presence in 20 countries throughout the five continents. The primary geographic areas where it operates, besides Spain, are North America (the United States and Canada), Latin America (Mexico, Chile, Brazil, Peru, Costa Rica, and the Dominican Republic) and Australia.

Where is Acciona based?

2011 and following its internationalisation process, ACCIONA began operations in Algeria to develop water supply and treatment projects. After South Africa, Egypt is the second country on the African continent in which ACCIONA is developing renewable facilities, although the prospect is to extend the implementation in this area in the coming years.

Why is Acciona a key player in the water treatment sector?

ACCIONA has positioned itself as a key player in the water treatment sector. Its innovative management seeks to resolve the challenges with respect to the shortage of water resources. The generation and use of energy accounts for 35 % of total greenhouse gas emissions in the world. This activity is the largest contributor to global warming.

In 2023, a new Sustainable Impact Financing Framework has been developed, which applies to ACCIONA (Acciona, S.A.) and its independently listed and financed subsidiary ACCIONA Energ&#237;a (Corporaci&#243;n Acciona Energ&#237;as Renovables, S.A.).

The Cabo Verdean company ELECTRA (Empresa de Electricidade e &#193;gua, SARL) has awarded the consortium consisting of ACCIONA Agua (60%) and SADE-CGTH (40%) the construction and start-up of two desalination plants on islands in the Republic of Cabo Verde. They will provide a service to more than 100,000 residents.
