

Who owns Ayala energy?

... AC Energy--a unit of billionaire Jaime Zobel de Ayala's Ayala Corp.--it has agreed to take full ownership of its Australian renewable energy joint venture as the Philippines' oldest conglomerate steps up investments to become the biggest listed renewable energy platform in Southeast Asia.

Will Ayala Land supply solar power to Alaminos?

AC Energy (PSE: ACEN) and Ayala Land have signed a power supply agreement for ACEN's 120 MW solar plant in Alaminos, Laguna to supply renewable energy that will help meet ALI's demand up to 2050.
