Cabinet is constitutionally responsible for exercising the general authority of Niueand has the general direction and control of the executive government of Niue. The Prime Minister is the leader of the government and the chair of Cabinet. He is elected by the Niue Assembly members at the Assembly's first meeting after a general election.

This comprises the Prime Minister and three other members of the Niue Assembly. Cabinet is constitutionally responsible for exercising the general authority of Niue and has the general direction and control of the executive government of Niue. The Prime Minister is the leader of the government and the chair of Cabinet.

Members are directly elected by universal suffrage, and serve a three-year term. Niue follows the Westminster system of government, with the Premier elected by the Assembly and the Cabinet drawn from it. The Assembly is descended from the Island Council established under the Cook Islands Act 1915.

Niue"s system of government is based on the Westminster system. The Niue Assembly consists of 20 members, 14 of whom are elected by village constituencies and 6 from the common roll. The 20 members elect a Prime Minister and the Prime Minister selects three cabinet ministers from the 19. Members elect a Speaker from outside their ranks.
