

The new company, Removr, will be 60% owned by Vanir Green Industries, a Nordic investment company committed to drive the energy transition, and 40% owned by GreenCap Solutions, a company controlled by the industry group BR Industrier. They are looking to develop the world's first 1-million-ton solid sorbent Direct Air Capture plant.

There were 8 new projects launched between December 2023 - January 2024 including GMN phase II (10 million EUR), Green Voyage2050 phase II (20 million USD), SMART-C Framework projects portfolio (5 projects with total of 20 million USD) and GloNoise project (2 million USD).
