How will citicore power raise money?

"The proceeds will be used to build new solar plants. We have 1,500 megawatts (MW) of solar pipeline projects," Citicore Power President Oliver Y. Tan told BusinessWorld in an online interview on Tuesday. The company is hoping to raise P8 billion to P10 billion in proceeds. It targets to have the offering in September or October this year.
