Official ties between the European Union and North Korea began in the years following the Cold War, precisely as the EU was developing its Common Foreign and Security Policy (CFSP).

With the 2004 and 2007 enlargements, the EU added Bulgaria, the Czech Republic, Poland, and Romania to its ranks. All the new member states, save Estonia, had ties with North Korea--dating back to the Soviet era for some members--or soon established diplomatic relations with Pyongyang.
