What happened to Hitachi ABB power grids?

Coinciding with its first-year anniversary, the global technology and market leader announces that it will be changing its name and corporate brand from October 2021. Hitachi ABB Power Grids today announced that it will be evolving to become Hitachi Energy from October 2021.

Does Hitachi have a power grid business?

Against this backdrop, Hitachi announced in December 2018 the acquisition of the power grid business of Switzerland's major heavy electric company, ABB Ltd, starting a new joint venture "Hitachi ABB Power Grids Ltd." which began operations on July 1, 2020.

Does Hitachi own ABB?

Tokyo, Japan and Zurich, Switzerland, July 1, 2020 --- Hitachi, Ltd. (TSE:6501, "Hitachi") today announced that it has completed the procedures for its 80.1% investment in the company operating power grids business that had been carved out from ABB Ltd (NYSE:ABB, "ABB"), pursuant to the acquisition agreement signed on December 17, 2018(1).

What does ABB's Power Grids business mean for Hitachi?

ABB's power grids business will strengthen Hitachi as a global leader in energy infrastructure and Hitachi will strengthen the position of ABB's power grids business as a global leader. Revenues of the business stood at \$10bn in the fiscal year 2017.

What's new at Hitachi energy?

"The energy landscape continues to evolve and so do we," said Claudio Facchin, CEO of Hitachi ABB Power Grids. He continued, "With our new name 'Hitachi Energy' we are broadening our commitment to creating further value for customers, our employees and society. The past year has been demanding for everyone, but we look forward with optimism.

When will Hitachi change its name to Hitachi energy?

Hitachi ABB Power Grids will change its name to Hitachi Energy from October. At the same time, we will change our corporate brand to the Hitachi brand and use it for external and internal communications. The business formally registered Hitachi Energy Ltd. on 30 June, 2021 and is now undertaking the formal process for the change of names globally.

In accordance with the agreement signed on December 17, 2018<sup>1</sup>, Hitachi Ltd. and ABB Ltd today announced the completion of all required procedures as planned, and the formation of Hitachi ABB Power Grids Ltd. Hitachi has an 80.1 percent stake in this new joint venture entity (which has business volume of approximately 10 billion USD<sup>2</sup>) and ABB holds the balance.

ABB has also agreed to provide transition services to Hitachi Energy to help them fully separate from ABB's systems. The deal is expected to close in the fourth quarter of this year subject to receiving regulatory approvals. Once it has closed, ABB expects net positive cash inflows of nearly \$1.425bn.
