Are rooftop solar panels expensive?

There's a problem: Rooftop solar panels are expensive, with prices in the tens of thousands of dollars putting them out of reach for many Americans. Newly expanded government programs, backed by \$7 billion in grants announced Monday by the Biden administration for Earth Day, aim to close that affordability gap.

Can I get a rooftop solar system if I have no income?

If no one in your home receives an income, you can also complete a zero-income affidavit, notarize it and fill out your application afterward. Every program is different, and you should reach out to your local provider to find out if you qualify for access to a rooftop solar system.
