The Government has launched a public call to develop Malta"s first offshore renewable energy project, located 12 nautical miles off the Maltese coast within the country"s Exclusive Economic Zone.

Malta will be issuing an international call for offshore wind turbines and solar panels next week, prime minister Robert Abela said on Friday. He announced this during a discussion with a number of young people addressing various subjects, including renewable energy, the environment, and women in politics.

Interconnect Malta has officially launched the Preliminary Qualification Questionnaire (PQQ) for the nation's first offshore floating wind farm. This project marks a significant milestone in Malta's journey towards carbon neutrality by 2050, as outlined in its Low Carbon Development Strategy (LCDS).

Malta"s Ministry for the Environment, Energy and Enterprise has issued a draft National Policy for the Deployment of Offshore Renewable Energy for public consultation and has demarcated six floating offshore wind development areas located beyond the country"s 12-nautical-mile territorial waters and into its potential Exclusive Economic Zone (EEZ).

"This policy paves the way for Malta to tap into the vast potential of offshore renewable energy, particularly floating wind and solar projects. By 2030, we aim to increase our share of renewables in the energy mix to 25%, and offshore energy will be instrumental in achieving this goal," minister Miriam Dalli said then.
