Why did Manx Gas rebrand to Isle of Man energy?

Manx Gas has rebranded to become Isle of Man Energy as it seeks to become 'more than a gas company'. The company says the change of name 'reflects the changing direction of the business' which will provide customers with choice in energy management solutions. It claims it will also support the Isle of Man's green energy transition.

Is ISLE OF MAN Energy a gas company?

Aidan Baglow,managing director of Isle of Man Energy,said: 'Our vision is to be more than a gas company. 'The current energy crisis means that,more than ever,customers are seeking ways to use energy more efficiently,so we are investing locally to provide additional products and services to help our customers achieve this.'

Why did Isle of Man energy change its name?

Aidan Baglow said the name change to Isle of Man Energy reflected a change in direction to include alternatives to natural gas. He said it also showed support for the island's move to net-zero emissions. It follows a 43.9% price hike for customers due to global volatility in the wholesale gas market.

Will Manx Gas support the Isle of Man's Green Energy Transition?

It claims it will also support the Isle of Man's green energy transition. Manx Gas was established in 1836. From 1 September the company increased its prices by 43.9 per cent, citing a significant rise in the cost of gas on the commodity market.
