Should lithium-based batteries be a domestic supply chain?

Establishing a domestic supply chain for lithium-based batteries requires a national commitment to both solving breakthrough scientific challenges for new materials and developing a manufacturing base that meets the demands of the growing electric vehicle (EV) and electrical grid storage markets.

What are base year costs for utility-scale battery energy storage systems?

Base year costs for utility-scale battery energy storage systems (BESS) are based on a bottom-up cost model using the data and methodology for utility-scale BESS in (Ramasamy et al., 2021). The bottom-up BESS model accounts for major components, including the LIB pack, inverter, and the balance of system (BOS) needed for the installation.

How much energy does a lithium secondary battery store?

Lithium secondary batteries store 150-250 watt-hours per kilogram(kg) and can store 1.5-2 times more energy than Na-S batteries, two to three times more than redox flow batteries, and about five times more than lead storage batteries. Charge and discharge efficiency is a performance scale that can be used to assess battery efficiency.
