

Where are the Marshall Islands located?

The Republic of the Marshall Islands (RMI) is situated nearly midway between Hawaii and the Philippines, and is the easternmost island group in Micronesia. The country consists of two parallel chains of atolls and islands in the central Pacific Ocean, known as the Ratak (Sunrise) chain and Ralik (Sunset) chain.

How many countries are in the Marshall Islands?

The Republic of the Marshall Islands has established bilateral diplomatic relations with 112 countries. Regional cooperation, through membership in various regional and international organizations, is a key element in its foreign policy. The Marshall Islands became a member of the United Nations on September 17, 1991.

What tertiary institutions are in the Marshall Islands?

There are two tertiary institutions operating in the Marshall Islands, the College of the Marshall Islands and the University of the South Pacific. The Marshall Islands are served by the Marshall Islands International Airport in Majuro, the Bucholz Army Airfield in Kwajalein, and other small airports and airstrips.

How many atolls are there in the Marshall Islands?

The Marshall Islands are one of only four atoll-based nations in the entire world. Austronesian settlers reached the Marshall Islands as early as the 2nd millennium BC and introduced Southeast Asian crops, including coconuts, giant swamp taro, and breadfruit, as well as domesticated chickens, which made the islands permanently habitable.

The Marshall Islands maintains embassies in the United States, Fiji, South Korea, Japan, and the Republic of China (Taiwan). What type of government does the Marshall Islands have?

Politically, the Marshall Islands is a parliamentary republic with an executive presidency in free association with the United States, with the U.S. providing defense, subsidies, and access to U.S.-based agencies such as the Federal Communications Commission and the United States Postal Service.
