

Who owns Mauritania's electricity plant?

Completed in 2017, the \$53 million plant is run by the national electricity company, Societ  Mauritienne d'Electricit  (Somelec), and has seen ongoing works since its inauguration by (then) President Mohamed Ould Abdel Aziz, removing an estimated 57,000 tonnes of CO 2 per annum and supplying 10% of Mauritania's net energy production.
