In May 2018,NextEra Energy announced that it planned to buy Gulf Power Company,the largest electricity producer in Northwest Florida,from Southern Company in a \$6.4 billion deal,pending approval from regulators.

What happened to NextEra Energy Resources?

In November 2016, NextEra Energy Resources sold two natural gas plants located in Marcus Hook, Pennsylvania and other assets to Starwood Energy Group. The sale totaled approximately \$765 million and included the combined-cycle Marcus Hook Energy Center (790 MW) and the simple-cycle Marcus Hook 50 Energy Center (50 MW).

How much is NextEra Energy worth in 2023?

In 2023,NextEra Energy's market value stood at over 150 billion U.S. dollars. The United States-based company is also one of the leading green electric utilities in the world,as its renewable energy capacity increased six-fold between 2005 and 2022.

NextEra Energy owns the wind farm,which began operating in 2002 NextEra Energy Resources,LLC (NEER) is a wholesale electricity supplier based in Juno Beach,Florida.
