

What is US - North Macedonia trade?

U.S. - North Macedonia trade through Q3 of 2021 totaled \$247 million, of which U.S. exports to North Macedonia were \$65 million. Member of European Free Trade Agreement (EFTA) and Central European Free Trade Agreement (CEFTA); bilateral Free Trade Agreements with Turkey and Ukraine.

What products did the US trade in North Macedonia in 2021?

The most successful U.S. trade products during 2021 in North Macedonia were engines and engine parts; chemicals; meat; poultry; other automotive parts and vehicle accessories; other industrial supplies; industrial machines; service industry machines; computers; and medical equipment.

Does North Macedonia rely on international markets?

That 19.1% for exports to overall GDP in PPP for 2023 compares to 21% one year earlier. Those percentages indicate a decreasing reliance on products sold on international markets for North Macedonia's total economic performance, albeit based on a short timeframe.

How much does North Macedonia export?

Selected examples are shown below. In macroeconomic terms, North Macedonia's total exported goods represent 19.1% of its overall Gross Domestic Product for 2023 (\$47.1 billion valued in Purchasing Power Parity US dollars). That 19.1% for exports to overall GDP in PPP for 2023 compares to 21% one year earlier.

Does North Macedonia have a trade deficit?

North Macedonia has had a foreign trade deficit since 1994, which reached a record high of \$2.873 billion in 2008, or 30.2% of GDP. Total trade in 2010 (imports plus exports of goods and services) was \$8.752 billion, and the trade deficit amounted to \$2.149 billion, or 23.4% of GDP.

Further BESS investment expected. Investment in BESS is predicted to continually grow over the course of the 2020s. McKinsey & Company analysis shows more than \$5 billion was invested in BESS in 2022, an almost threefold increase from the previous year. Looking ahead, it's expected the global BESS market will reach \$120-\$150 billion by 2030.
