Across the country, prosecutors are investigating high-pressure sales tactics and misleading financing arrangements.

The FTC received 5,331 complaints containing the phrase "solar panels" between Jan. 1 and Sept. 19 of 2023, up 31% from the entire year of 2022 and up 746% since 2018, when it received just 630 complaints.
