The South Sandwich Islands, actively volcanic, consist of a 390-km-long chain of 11 main islands. The United Kingdom claimed sovereignty over South Georgia in 1775 and the South Sandwich Islands in 1908. The territory of "South Georgia and the South Sandwich Islands" was formed in 1985; previously, it had been governed as part of the Falkland Islands Dependencies.

What is the ccTLD for South Georgia and the South Sandwich Islands?

The Internet country code top-level domain (ccTLD) for South Georgia and the South Sandwich Islands is .gs. The parts of the islands that are not permanently covered in snow or ice are part of the Scotia Sea Islands tundra ecoregion.
