Why has Taiwan changed its approach to environmental management?

In response to the international trend towards net-zero emissions and other global environmental changes, the government has changed its approach from "management of natural resources" to "actively responding to the global environmental situation and creating opportunities for Taiwan's transformation".

Does Taiwan have an environmental problem?

In the past twenty years, Taiwan has seen a surge in environmental organizations, which to a certain degree have enjoyed a remarkable success in fighting polluting industries or affecting environmental policies. While the situation has improved greatly since the 1990s, several issues remain unsolved.

What is Taiwan air quality monitoring network?

In 1993,the Taiwanese government developed the Taiwan Air Quality Monitoring Network,which includes a large-scale deployment of air monitoring stations,to record and forecast the air quality6. This network has been operating for over 25 years and its data are open to the public.

How many air monitoring stations are there in Taiwan?

The large-scale database used in this study was built by the official EPA and Central Weather Bureau (CWB). The database contains more than 260,000 samples taken in 2017 from 77 air monitoring stations(from the EPA) and 580 weather stations (from the CWB) in Taiwan. Fig. 1 (a) displays the geographical positions of the 77 air stations.

Does Taiwan have quality assurance operations for air quality monitoring?

Taiwan's EPA has strict regulations and guidelines in regards to quality assurance operations for air quality monitoring to achieve the EPA's data quality objectives (DQO). Every year the EPA has to perform quality assurance operations for the air quality monitoring system in order to evaluate the accuracy of air quality measurements.

How can Taiwan moenv improve CEMS Management System?

In order to strengthen the CEMS management system and make the pollution source control and monitoring management system more complete, Taiwan MOENV continuously improve the quality and reliability of monitoring data, strengthen inspection and control measures, and implement a full-time monitoring requirements.
