Does rooftop solar have a fraud problem?

Rooftop solar has a fraud problem. The industry is working to build back trust A crew installs a solar array on the roof of a home in Frankfort, Ky., in 2023. PHILADELPHIA -- The solar power industry is booming and that growth helps the world meet its climate goals by replacing fossil fuels.

Why are prosecutors investigating rooftop solar?

Across the country, prosecutors are investigating high-pressure sales tactics and misleading financing arrangements. Some customers say they were victims of fraud and forgery. This threatens rooftop solar's impressive momentum. Now, some solar companies are working to repair the industry's reputation.

How many complaints are there about solar-panel salespeople?

Meanwhile, consumer complaints about solar-panel salespeople have skyrocketed in recent years. The FTC received 5,331 complaints containing the phrase "solar panels" between Jan. 1 and Sept. 19 of 2023, up 31% from the entire year of 2022 and up 746% since 2018, when it received just 630 complaints.

Are people deceived by solar financing companies?

We don't want people deceived, though," says Adam Welle, a lawyer with the Minnesota Attorney General's Office who is pursuing a case against solar financing companies. Beyond the industry's reputation, real people - many of them already financially vulnerable - have been hurt.

Are solar panels a problem for retired machinists?

On his roof there are solar panels. They generate electricity but also have become a source of frustration for the retired machinist. In December 2022, Minto says a door-to-door salesman approached him about a government program to help senior citizens save on their electric bills. "Well, everybody wants a cheaper electric bill, right?" Minto says.

Do solar companies have a Consumer Protection Bureau?

Some states also have consumer protection bureaus where consumers can file complaints. While the advisories are an attempt to educate consumers, previous government efforts to regulate solar companies have fallen short.
