Except for Midway Atoll, the Pacific islands are surrounded by large exclusive economic zones and are within the bounds of the Pacific Remote IslandsMarine National Monument. They are collectively represented by the ISO 3166-1 alpha-2 code UM. The individual islands have ISO 3166-2 numerical codes.
