Hazardous waste testing on solar panels in the marketplace has indicated that different varieties of solar panels have different metals present in the semiconductor and solder. Some of these metals,like lead and cadmium,are harmful to human health and the environment at high levels.

Are solar panels a hazardous waste under RCRA?

If these metals are present in high enough quantities in the solar panels, solar panel waste could be a hazardous waste under RCRA. Some solar panels are considered hazardous waste, and some are not, even within the same model and manufacturer.
